TERMS & CONDITIONS

GENERAL TERMS

- 1. We do not require a certificate proving your English language skills, but participants should be aware that the language of the Summer School is English and that good command of the English language is required to follow the lectures.
- **2.** The deadline for applications for Innovation and Technology Law Summer School is 30 April 2018
- **3.** Please send us your application using this application form.

ACCEPTANCE AND PAYMENT

- **4.** To be accepted as a participant of the Summer School, you have to complete the applicant form and to submit the proof of payment to the Administrative Office of the Summer School (at itlaw.unipd@gmail.com). Without the proof of payment, the only application form does not allow the acceptance to the School. The Administrative Office will send you an invoice, when you are accepted.
- **5.** If you submit the application form, but you fail to make the payment, the School may give your place to another applicant, until the proof of payment is given.
- **6.** After receiving the full fee for the Summer School, we will send you a letter of acceptance and an invitation to take part in the Summer School.

CANCELLATION AND WITHDRAWAL

- **7.** The maximum number of participants to the Summer School is thirty. For the purpose of this Regulation, the criterion of first receipt shall be referred as "first come first served" principle: in other terms, the first thirty applicants who send their application form fulfilled and the payment receipt to the Administrative Office of the Summer School (at itlaw.unipd@gmail.com) will have guaranteed admission to the school.
- **8.** In case you withdraw from taking part in the Summer School during the fifteen days before the beginning of the School, the amount payed by the applicant shall be completely forfeited. If you withdraw in advance (more than 15 days before the beginning of the School), the School can only give you a refund of the tuition fee paid less the costs incurred by us at the time of the withdrawal. Please note that the institute has to make certain expenses (administrative costs, post fees, booking fees, etc.) a certain time prior to the beginning of the summer school.

FINAL PROVISIONS

- 9. This agreement is governed by Italian law and subject to the jurisdiction of the courts of Italy.
- **10.** In case any clause is found invalid or inapplicable by a competent court, this does not affect the validity or applicability of any other clause of this agreement.

- I confirm that the information I have given in my application is correct.
- I accept that I am responsible for obtaining a Visa (if needed). I accept that I am responsible for my health insurance during my stay in Padua.
